### Uniform Standards and Conformity

Please can you ensure that your child is wearing the full, correct Rhosnesni uniform. Skinny trousers, knee high/over the knee socks and trainer style socks are **not permitted**. Skirts must **knee length**. Synthetic nails, gels and false lashes are **not appropriate** for school, and pose a health and safety risk. The following items are **not permitted**: facial piercings, necklaces, rings, bracelets or heavy makeup or nail varnish.

### For All Parents/Carers of Students in Years 7, 8 and 9.

This is to advise you that your son/daughter will be involved in Personalised Assessments during this term. Personalised assessments are statutory for learners in Years 2 to 9 in maintained schools in Wales. The assessments that will take place will include Numeracy (Procedural), Numeracy (Reasoning) and Reading. The tests are available for schools to use to support students to make progress.

Staff will prepare students for the tests in class and let them know when they will be taking place. The link below gives further information for parents/carers.

It is essential that students are equipped for these assessments. The Procedural test requires simply a pen for workings while the assessment is being completed. The Reasoning test requires a calculator. Students will not be allowed to use a mobile phone, smart watch or the calculator function on the computer.
